MAYOR'S MESSAGE

Spring has finally arrived. While it seemed like a long winter, it was a breeze compared to last year's winter. It's March 22nd when I'm writing this and it's sunny and 65 degrees. Last year I wrote my April message on the same date. March 22nd last year was 32 degrees and snowing heavily. Spring did come one day earlier this year because it's a leap year, so spring officially sprung on the 19th. We are not anticipating any flooding problems this year even though it has been an above average snowfall. Having said that, please be aware and alert of any flooding problems. One thing I have found out is that Mother Nature has a sense of humor, and you can never be 100 percent certain about anything weather related. Keep an especially good watch on any small streams that will have drainage from the mountain and be vigilant in keeping children and pets away. These small streams can be very deceiving and can be icy, cold, fast-moving, and change quickly depending on the weather.

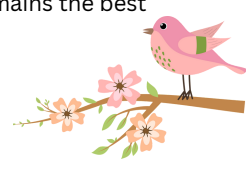

OPEN BURN PERMITTING

The open burning window is now underway and ends May 30th. After obtaining a burn permit remember to follow these guidelines:

1. The clearing index must be above 500 in order to burn legally.
2. Only yard waste and vegetation may be burned (tree clippings, leaves, and grass).
3. Fire must be attended at all times and out by dark.
4. Some type of extinguishing method must be present (water, shovel, etc.).
5. North View Fire Department reserves the right to extinguish any fire that is deemed a public nuisance.
6. Open burn season is for all residents and property owners. Please burn responsibly and follow the attached link to obtain a burn permit.

Pineview Water will begin filling the secondary water systems on

April 15, 2024

The system will not be fully pressurized until all repairs are made throughout the entire system. This can take from one week to one month, depending on the severity of mainline breaks over the winter months.

MAKE SURE YOUR MASTER VALVE IS SHUT PRIOR TO APRIL 1st!

- WAIT TO WATER UNTIL YOUR LANDSCAPE NEEDS IT.
- NO WATERING BETWEEN 10 AM & 6 PM.
- NO WATERING ON CONSECUTIVE DAYS.
- NO WATERING FOR EXCESSIVE LENGTHS OF TIME.
- REPAIR WATER LINES & SPRINKLER HEADS ASAP.
- DON'T LET YOUR WATER RUN DOWN THE GUTTER OR ONTO NEIGHBORING PROPERTIES.
- DON'T ALLOW SPRINKLER HEADS TO SPRAY THE STREET, SIDEWALKS OR OTHER HARD SURFACE AREAS.
