- 1. Discussion and possible action items relative to the Rockwell Estates Subdivision development. This includes various actions and the following considerations:
 - a. Development Agreement
 - b. Escrow Agreement
 - c. Consideration of Protection Strip Agreement
 - d. Final Plat Approval

<u>Dana Shuler</u> presented all of the agreements and the final plat approval. There was a rousing discussion specifically about how interest will be calculated in the Protection Strip Agreement. The decision was made to make the following changes to the Protection Strip Agreement:

A. Reimbursement. Developer agrees that reimbursement shall be in accordance with City Code, generally consisting of the Cost of Improvements and Land, as shown in Exhibit B, together with a fair rate of interest, not compounded interest, as defined by the Federal Open Market Committee (FOMC) and/or Internal Revenue Service (IRS) current interest rate averages, not compounded interest, that shall be negotiated between the Developer and the adjacent property owners at the time of future

development. In no case shall the reimbursement exceed the initial cost of the improvements and land as set forth in this agreement, plus ten percent (10%) of the cost of improvements and land, compounded annually that Developer has owned the protection strip.
