3. Public Hearing - Rezone. Discussion and possible action to consider a proposal for a rezone of 0.80 acres of land from Planned Manufacturing (MP-1) to Manufacturing/Commercial Mix Zone (MCM) at 2709 North Rulon White Blvd, Ordinance 2022-31. (Presenter: Amy Mabey)

Motion was made by <u>CM Urry</u> to go into a public hearing to consider a rezone of 0.80 acres of land from Planned Manufacturing (MP-1) to Manufacturing/Commercial Mix Zone (MCM) at 2709 North Rulon White Blvd. 2<sup>nd</sup> by <u>CM Nelsen</u>. Voting aye: CM Arrington, CM Gibson, CM Marriott, CM Nelsen and CM Urry. 5-0

<u>Amy Mabey</u>: this is a proposed rezone from MP-1 to MCM. The planning commission has recommended approval. The area was shown on Rulon White Blvd. The applicant wants to expand the area to include an RV dump and diesel fueling. It makes sense. The current zone

doesn't allow the use. If approved the site plan will be considered at planning commission. <u>CM Nelsen</u>: is Trigon in a MCM zone? <u>Amy Mabey</u>: yes. <u>CM Gibson</u>: this is a great thing. It will bring in sales tax. <u>Amy Mabey and CM Nelsen</u> read aloud some of the uses allowed in the MCM zone. <u>Amy Mabey</u>: MCM mainly allows for more commercial uses.

Motion was made by <u>CM Urry</u> to approve the rezone in item #3 from MP-1 to MCM at 2709 North Rulon White Blvd, Ordinance 2022-31. 2<sup>nd</sup> by <u>CM Nelsen</u>. Roll call vote. Voting aye: CM Arrington, CM Gibson, CM Marriott, CM Nelsen and CM Urry. 5-0

# 4. Preliminary Subdivision. Discussion and possible action to consider approval of a preliminary subdivision application for Parkland II Planned Unit Development (PUD) at 2738 North Rulon White Blvd. (*Presenter: Amy Mabey*)

Amy Mabey: this went to the planning commission on October 20, 2022 and it was a unanimous recommendation of approval. It is a subdivision of three lots. It is in the MP-1 zone. The staff report was reviewed. It meets the zoning. The location and proposed plat was shown. CM Marriott: what are the manufacturing types? Amy Mabey: they are leasing out the buildings. Brent Bailey: we are selling one to a cabinet shop and the others are leased. They will have separate meters and connections. One building is being leased to Bird and Basketball. Amy Mabey: the next step is final subdivision approval.
